Updates:

- No overnight parking in guest parking areas: You will be ticketed and could have your vehicle towed. You can get a permit for temporary parking in the guest parking from Pete Vistaunet, @ 801.878.7178 or from Jaline Zoun @ 801.450.3700 HOA Board Members.
- Please make sure you keep your overhead garage doors closed and home doors locked at all times.
- Curb and <u>leash</u> your pets and take their garbage home with you.
- **Barking dogs** in excessive continuous or untimely fashion is prohibited; to report, contact SL County Animal Control at 385.468.7387.
- **Correction**: The **posted** speed limit in our Community is 15 MPH (see posted signs at entrances). The Board discovered that our Community Rules and Regulations states 20 MPH. As of 10/20/15 HOA Board meeting this issue was discussed and Board Member vote was to notify Owners that the Rules and Regs. will be changed to read "posted speed limit" of 15 MPH. (section IV Rule 2)
- Make sure the pedestrian walking gates are closed behind you. If you need the pedestrian gate code, call M&M Management. Thanks!
- If you need help finding maintenance "help" call M&M Management at 801.566.1411.
- Fall flower bed and leaf clean up is in process.
- All seasonal outside decorations are installed at Owner's own risk.
- Watch out for snow plow markers; they will be installed soon.
- Communications with M&M regarding problems or requests need to be in writing or e-mail format so that there is a paper trail of these communications.
