This basic rate includes one (1) digital box with “on demand” and 2 additional boxes. Basic bulk rate service is fully upgradeable. If a resident wants to subscribe to any additional services above this on their own, call Comcast, Bulk Customer Support number at **888-895-6504** to make arrangements for upgrades.

This basic bulk package also includes access to “on the go apps”, allowing you to watch TV on your mobile devices when outside of the home or traveling.
